OUTINGS

Children benefit from being taken out of the Pre-school to go on visits or trips to local parks or other suitable venues for activities which enhance their learning experiences.

Outing Procedures.

- Parents sign a general consent on registration for their children to be taken out as a part of the daily activities of the setting.
- Parents are always asked to sign consent forms before major outings.
- A risk assessment is carried out before any outing takes place.
- On outings we endeavor to maintain a high adult to child ratio, normally one adult to three children, depending on their age, sensibility and type of outing.
- Children are assigned to each staff member to ensure each child is individually supervised and accounted for.
 - Outings are recorded on an outings risk assessment sheet.
 - ★ At least two staff mobile phone are taken on outings, and a mini first aid pack. The amount of equipment will vary and be suitable for the venue, the number of children and time they will be out for.
 - ✤ A record of the contact numbers of parents are carried.
 - * Whilst keeping to our adult: child ratio a minimum of two staff should accompany children on outings, of which one must hold a First aid certificate; and a minimum of two staff members should remain behind with the rest of the children of which one must hold a First aid certificate and a level 3 childcare qualification.

Procedures for a Lost Child on an Outing

If parents are in attendance they are responsible for their own children. When a staff member is responsible for a child, the following procedure will take place.

- As soon as it is noticed that a child is missing, staff on the outing ask children to • stand with their designated person and carry out a headcount to ensure that no other child has gone astray. One staff member searches the immediate vicinity but does not search beyond that.
- The parents are informed to come immediately to the Pre-school or outing venue and the Police are contacted. (if appropriate).
- If local, staff members take the remaining children back to the setting while staff continue to search the area the child was last seen.
- In an indoor venue, a member of staff would contact the venue's security who will conduct a search and contact the police if the child is not found.

- The Manager and Chair carry out a full investigation taking written statements from all the staff who were on the outing.
- > The date and time of the report.
- What staff/children were in the group/outing and the name of the staff member who was responsible for the missing child.
- > When the child was last seen in the group/outing.
- > What has taken place in the group/outing since the child went missing.
- > The time it is estimated that the child went missing.
- If the incident warrants a police investigation, all staff co-operate fully. In this case, the police will handle all aspects of the investigation, including interviewing members of staff. Children's Social Care may be involved if it seems likely that there is a child protection issue to address.
- The incident is reported under RIDDOR arrangements (see Reporting of Accidents and Incidents); the local authority Health and Safety Officer may want to investigate and will decide if there is a case for prosecution.
- In the event of disciplinary action needing to be taken, Ofsted is informed.
- The insurance provider is informed.

Pre-school Annual Day Out.

The Committee is responsible for organizing a whole group excursion. On these occasions, parents/carers accompany their own child/children and are responsible for transportation to/from the venue. Whilst Pre-school staff may accompany both parents and children on these outings, they do not have any children in their care and are not therefore responsible for their welfare.

Outings to the Local Shops.

To extend the children's learning of the curriculum, children may accompany a minimum of two members of staff to visit the shops. On these outings the following guidelines apply:

- Ratio is 1 (one) adult to maximum 3 children. (Minimum of 2 staff.)
- Children are taught to observe and practice road safety.
- An outing may only take place providing ratios of 1:4 for under 3 years and 1:8 for 3-5 years are maintained for the remaining children at pre-school.

Forest School

Refer to Forest School risk assessment and hand book for all policies and procedures relating to children attending the Forest school sessions.
